NOTICE OF PUBLIC HEARING
CITY COUNCIL ELECTION DISTRICT BOUNDARIES**

NOTICE IS HEREBY GIVEN that the City Council of the City of Yucaipa will conduct a public hearing per Elections Code Section 21607.1 on November 8, 2021, at 6:03 p.m., at Yucaipa City Hall in the City Council Chambers located at 34272 Yucaipa Boulevard, Yucaipa, CA 92399, at which time the City Council will conduct the second Redistricting Public Hearing and: (1) Receive a report from the City's Consultant, National Demographics Corporation, (NDC) on the redistricting process and permissible criteria to be considered to redraw district boundaries; and (2) Discuss "neighborhoods" and "communities of interest"; and (3) Receive public input on district boundaries.

All interested persons are invited to attend said hearing and express opinions related to this matter.

Public comment via mail or email for this Public Hearing must be submitted no later than three (3) business hours prior to the meeting at which the commenter seeks to provide comment. Public comment may be submitted via U.S. Mail to the City Clerk at 34272 Yucaipa Blvd., Yucaipa, CA 92399 or via email to redistricting@yucaipa.org. All mail and email correspondence will be archived, distributed to City Council, and retained as part of the public record; however, submissions will not be read out loud during the meeting. The subject line should specify "Public Comment" and include the date of the meeting.

Written public comment will be made available to the public pursuant to the City of Yucaipa policy regarding the distribution of written public comments at City Council and Commission meetings, which may be accessed on the City's website at <https://yucaipa.org/agendas-minutes/>. Individuals should be aware that comments provided, including personal information, may be disclosable pursuant to the California Public Records Act.

All staff reports and supporting documentation will be available for review in the office of the City Clerk at 34272 Yucaipa Boulevard, Yucaipa, CA 92399, and on the City's website at <https://yucaipa.org/yucaipa-redistricting/> on and after November 4, 2021.

Please contact the City Clerk's office at 909-797-2489, ext. 230, if live translation in an applicable language (Spanish), as determined by the Secretary of State, is needed for this hearing. Notification 72 hours prior to the meeting is required to enable the City to make reasonable arrangements.

If any matter proposed herein is challenged in court, there may be a limitation to raising only those issues at the public hearing described herein, or in written correspondence delivered to the City of Yucaipa at, or prior to, the public hearing.
